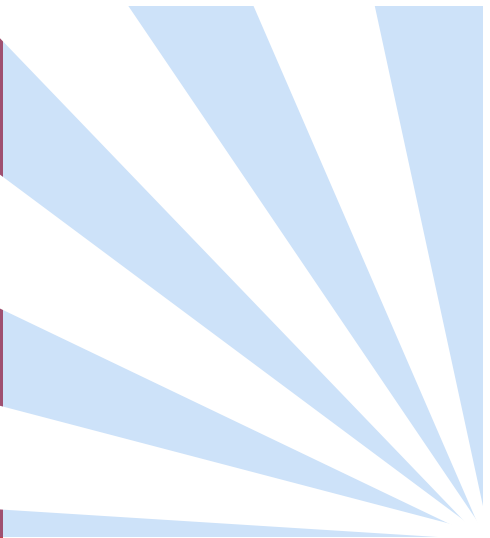
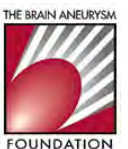

From The Director of The Medical Advisory Board

In 2007, the Brain Aneurysm Foundation took on the exciting initiative of research funding. During the first year of this funding, two grants were issued for a total of \$20,000. In 2008, three grants were initiated for a total of \$40,000, and in 2009, we project that six grants will be awarded for a total sum of \$145,000. This makes the total research funding \$205,000 so far specifically dedicated to research for brain aneurysms directed at early detection, improved treatment modalities, and technological advances that will ultimately improve outcomes for patients with brain aneurysms. The Brain Aneurysm Foundation has become the leading source of private funding of brain aneurysm research worldwide.

The research conducted has been both basic science and clinical. To date, some exciting work has been produced learning about the relationship of size and shape of aneurysm to potential for hemorrhage. This kind of research relates directly back to patients and the possibilities of hemorrhage related to aneurysm morphology.

It will remain a significant goal of The Brain Aneurysm Foundation to continue efforts to raise funding for research activities. This has gained The Brain Aneurysm Foundation national and international recognition in the treatment of brain aneurysms.

For the many families who have lost loved ones as a result of aneurysm rupture and for those whose outcomes are a challenge, The Brain Aneurysm Foundation strives to find better ways to detect aneurysms earlier and to improve treatment, promoting a better quality of life for all aneurysm patients and their families.

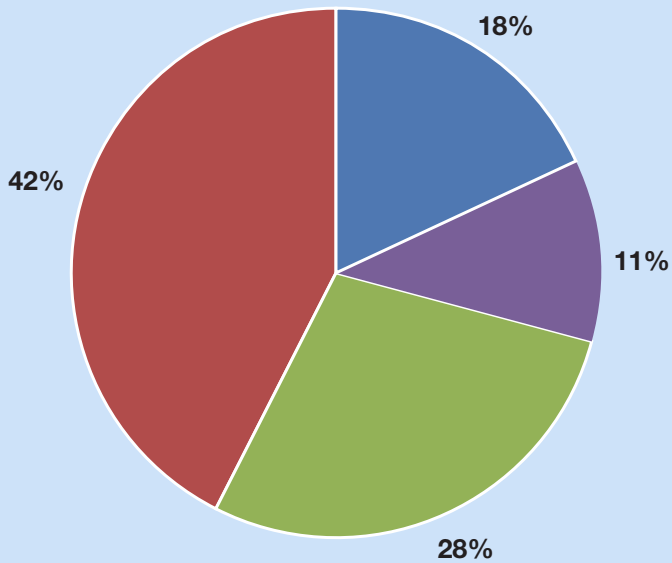

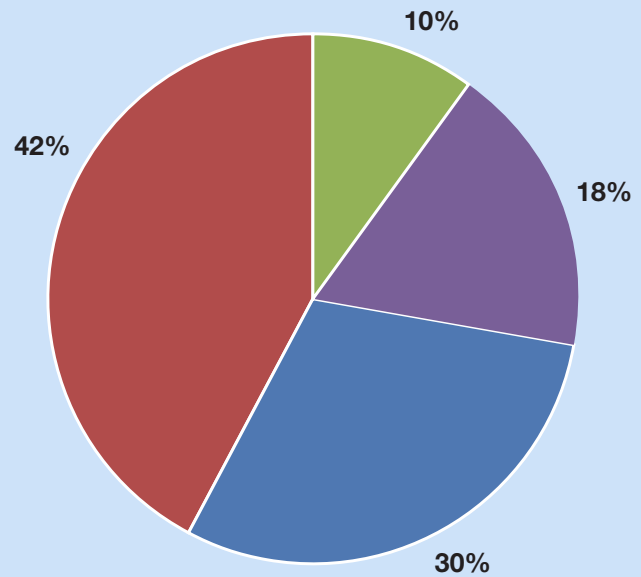

2008 Award Recipients:

The Cynthia Lynn Sherwin Chair of Research Dr. Bernard Bendok Northwestern University

“An Investigation of Inflammation Related Genes and CXCR4 in Human Cerebral Aneurysms” Dr. Bendok’s study aims to better define the role of in” Dr. Bendok’s study aims to better define the role of inflammation in brain aneurysms to potentially open avenues for prevention, early detection, screening and therapy. His study will use gene chip analysis to identify inflammation related genes and what different characteristics these genes have when found in an aneurysm versus a different artery in the brain.

Dr. Douglas Cook Toronto Western University Research Institute

“Endothelial and vascular smooth muscle differential gene expression in macro and microcirculatory vasospasm following subarachnoid hemorrhage” Dr. Cook’s research hopes to identify specific genes which are related to a condition called vasospasm, which is the narrowing of a blood vessel after it has been in contact with blood after aneurysm rupture. He also wishes to find out the mechanism by which vasospasm occurs, such as whether or not there is a chain reaction of events that could identify protective or degenerative factors on the cellular level.

The Shirley Dudek Demmer Chair of Research Dr. Satoshi Tateshima The Regents of UCLA

“Histopathology and Hemodynamics During the Growth of Brain Aneurysms” The growth of brain aneurysm size may be a sign of degeneration and weakening of the aneurysm wall. Dr. Tateshima’s research will study how and why the wall of the aneurysm weakens over time in the hopes of helping doctors make appropriate clinical decisions in the management of patients with a small aneurysm that show some change in shape and size over time. Investigators will look at brain aneurysm cells, study the interaction of some proteins in those cells, the shape and size of aneurysm as they grow, and how blood flow inside and around the aneurysm can affect aneurysm growth and or rupture.

U.S. Senate Backs Brain Aneurysm Awareness

The Brain Aneurysm Foundation would like to thank Senator John Kerry of Massachusetts for making a statement on the floor of the U.S. Senate on September 30, 2008 in support of brain aneurysm awareness, education, and research.

In addition, in 2008, Nebraska, Michigan, Pennsylvania, Massachusetts, Florida, New York and Illinois all declared September as Brain Aneurysm Awareness Month. During Brain Aneurysm Awareness Month, healthcare centers across the nation participated in brain aneurysm awareness outreach programs.

Outreach in the Medical Community

During 2008, The Brain Aneurysm Foundation attended and had a booth at three national neurological conferences. Having a presence at these conferences is important, in order to meet the medical professionals in the field who care for and treat brain aneurysm patients. This gives the BAF the opportunity to make the medical community aware of the services The Brain Aneurysm Foundation can provide them and their patients.

New Brain Aneurysm Awareness Brochure Published

In 2008, over 20,000 brochures entitled “Food for Thought: Brain Aneurysm Basics That Can Save Your Life” were distributed during Awareness Month as well as throughout the year at hospitals, healthcare facilities and at community events. Chef Mario Batali, of The Food Network, a brain aneurysm survivor, was interviewed for the new fact brochure, which was published in both English and Spanish.



Support and Educational Services

The Brain Aneurysm Foundation developed from a close relationship between patients and healthcare professionals who identified the need for comprehensive information and support for brain aneurysm patients, their families, and the medical community. The BAF provides educational literature to brain aneurysm patients, their families, and the medical community in both English and Spanish. In addition, The Brain Aneurysm Foundation eases the diagnosis, procedural and recovery process for survivors and families by providing phone support, email support, support groups, and our website. Our Internet presence has grown and the BAF website receives over 25,000 hits per week.
